Assessment activity 1

Promoting inclusion

Purpose

This assessment activity is designed to assess your skills and knowledge in promoting inclusion.

Requirements

To complete this assessment activity, you need:

- access to a children's services environment
- to answer the questions and submit responses as directed by your trainer/assessor/training organisation
- access to the Early Years Learning Framework and the United Nations Convention on the Rights of the Child.

Part A

It is essential that you promote inclusion. To do so you must:

- make curriculum decisions that promote participation
- demonstrate actions that assist, support and encourage children to participate
- interact with families and children in ways that show you believe in their capacity to succeed
- work with others within and outside of your service to develop your professional knowledge of people with different needs.

The following are some people and services that can support you to do these things:

- a) Families of children with additional support needs
- b) Educational leaders
- c) Professional Support Coordinators (PSCs)
- d) Inclusion Support Agencies (ISAs)
- e) Services within the community that specialise in supporting children with specific additional support needs

Explain and provide evidence to show how each of these people and services assist you to promote inclusion. You might provide evidence such as:

- documents
- pamphlets, leaflets or flyers
- website addresses
- notes from discussions
- points based on your knowledge.

Part B
